**Registration Fees** – Pre-registration is strongly encouraged, but not required. Registration made on or prior to April 10, 2017 (postmark date for registrations through the USPS) is \$150 (Member/Associate Member price - \$100). Registration made during April 11 through April 24, 2017 is \$175 (Member/Associate Member price - \$125).

**Late Registration Fee** – Registrations made on or after April 25, 2017 are subject to a **\$25** late registration fee. This fee is in addition to the Registration Fees listed above.

**NSF Fees** – A Non-Sufficient Funds fee will be assessed for any check payment returned for insufficient funds or closed account.

**Guests/Alternates** – All guests must register to attend and are subject to all associated terms and conditions. Alternates may attend if registered attendees are not available on the conference dates.

**Cancellation Policy** – Our cancellation policy is intended to keep costs low for attendees.
